#### WPKR'S "RASCAL ONLINE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WPKR ("Station"), 491 South Washburn Street, STE 400, Oshkosh, WI 54904, during available business hours Monday through Friday, on the Station website www.995pkr.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WPKR's "Rascal Online"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

## 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
